PHASE II: New State Replacement Forms

Transition Rules for Phase II

There is a 60 day transition period that begins on July 18, 2016, and will end on September 17, 2016. Prior versions of the state replacement forms will be considered NIGO (Not In Good Order) on or after September 18, 2016. Beginning September 18, 2016, the new replacement forms for the above states must be used (when applicable) for new business to be considered in good order.

PHASE III: New State Replacement Forms

Effective August 8, 2016, American General Life Insurance Company will require new state replacement forms to comply with the replacement regulations for the following states:

Beginning October 8, 2016, the new replacement forms for the above states must be used (when applicable) for new business to be considered in good order.
